Overview

Claire joined Chambers in 2016 and is quickly building up a busy practice. From June to September 2017, Claire was seconded to the legal department of Times Newspapers Ltd. During her secondment, she handled complaints on a variety of matters including copyright and IP SO complaints.

In 2018, Claire was awarded a Pegasus Scholarship to participate in the Paris Bar Exchange. She spent one month attending a variety of court and arbitration hearings, and sat with the media and information team at leading French law firm, Granrut.

Before commencing pupillage, Claire spent a year working in the litigation team of a multinational energy company. In 2013-14, she was editor and communications manager of the Oxford Human Rights Hub and continues to write for it regularly on the topics of freedom of expression and privacy. In 2014, she co-edited the Hub's inaugural published anthology, "*Global Perspectives on Human Rights*" and its annual report.

Representative Cases

Defamation

Stocker v Stocker UKSC 2018/0045 (2019) - Junior counsel for the claimant/respondent (led by One Brick Court's Manuel Barca QC) in an appeal to the Supreme Court in a defamation claim arising from allegations published by the defendant/appellant on Facebook.

K&K Hire Limited and anr v Radio Taxis (Southampton) Limited (2018) - Counsel for the defendant in a successful application for strike out and summary judgment in respect of both claimants' claims in defamation.

Churchil Ltd v The Office of Qualifications and Examinations Regulation (2018) – Counsel for Ofqual in a claim originally brought in defamation, breach of the Data Protection Act 1998, and unlawful interference in business.

Osborn v Phillips (2017) – Counsel for the defendant in a libel, data protection and harassment claim.

Obileye v Williams and anr (2017) – Counsel for the defendants in an application to strike out a defamation claim.



Wallwork and others v McDowall and another (2016) – Counsel for the defendants in a successful application to strike out a defamation action for *Jameel* abuse of process and failure to surmount the serious harm threshold in section 1 of the Defamation Act 2013.
